## **RESOLUTION NO. 2021-347**

A RESOLUTION OF THE CITY COMMISSION AUTHORIZING THE EXECUTION OF A SERVICE AGREEMENT WITH THE TRANE COMPANY FOR THE PUBLIC SAFETY BUILDING'S, LOCATED AT 2151 SALZEDO STREET, MAINTENANCE AND SERVICE OF THE TRACER AUTOMATION SYSTEM, IN THE AMOUNT OF \$216,265 FOR MAINTENANCE SERVICES TO BE PERFORMED.

- **WHEREAS**, the City's Public Safety Building is a state-of-the-art facility, with multiple energy efficient components; and
- **WHEREAS,** one of these components includes Trane's Tracer Building Automation System; and
- **WHEREAS**, this system controls the building's HVAC system which allows for energy efficiency and a quick diagnosis of its equipment; and
- **WHEREAS**, South Florida Trane is the only controls manufacturer/representative and the Sole Source factory-authorized servicer for the Tracer Building Automation System; and
- **WHEREAS**, this agreement will provide services that include troubleshooting and correcting problems in Trane's HVAC system, pre-maintenance, maintenance repair, emergency repair, and other related work; and
- **WHEREAS**, this service agreement will be for (5) years, starting fiscal year 2021-2022 and will allow for yearly renewal options thereafter;

## NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

- **SECTION 1.** The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.
- **SECTION 2.** That the City Commission approved the service agreement with the Trane Company in the amount of \$216,265 starting fiscal year 2021-2022 and allow for yearly renewal options thereafter.

**SECTION 3.** That this Resolution shall become effective upon the date of its adoption herein.
