A RESOLUTION OF THE CITY COMMISSION AUTHORIZING THE BUSINESS IMPROVEMENT DISTRICT OF CORAL GABLES (BID), TO SELL ALCOHOLIC BEVERAGES FROM 12:00 P.M. UNTIL 12:00 A.M., AT THE PLAZA LOCATED ON THE 100 BLOCK OF GIRALDA FROM PONCE DE LEON BOULEVARD FROM PONCE TO GALIANO STREET, ON MARCH 17, 2018, DURING THE "*ST. PATRICK'S DAY ON GIRALDA PLAZA*" EVENT, SUBJECT TO FLORIDA DEPARTMENT OF PROFESSIONAL REGULATION REQUIREMENTS.

BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. In an effort to activate the new Giralda Plaza space, the BID will be providing a family friendly environment themed, with games and entertainment for all ages. Live music and other entertainment will continue until midnight on the plaza.

SECTION 2. That the request of the Business Improvement District of Coral Gables (BID) to serve alcoholic beverages during the "*St. Patrick's Day On Giralda Plaza*" event, from 12:00 p.m. until 12:00 a.m. at the Plaza located on the 100 Block of Giralda from Ponce de Leon Boulevard to Galiano Street on March, 17, 2018 is approved.


