**RESOLUTION NO. 2025-239**

A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE RECOMMENDATION OF THE CHIEF PROCUREMENT OFFICER TO APPROVE A CONTRACT MODIFICATION TO INCREASE THE SPENDING AUTHORITY ON THE NASPO VALUE POINT MASTER CONTRACT AGREEMENT # 00318 - PUBLIC SAFETY COMMUNICATION PRODUCTS SERVICES AND SOLUTIONS IN THE ESTIMATED AMOUNT OF \$4,065,113.19, PURSUANT TO SECTION 2- 764 (B) OF THE CITY' S PROCUREMENT CODE ENTITLED CHANGE ORDERS AND CONTRACT MODIFICATIONS".

**WHEREAS**, on January 1, 2022, the City officially accessed NASPO Value Point master contract # 00318 for Public Safety Product, Services and Solutions that was # awarded to Motorola Solutions, Inc.: and

**WHEREAS**, the contract is primarily utilized for the purchase of public safety communication equipment that specifically includes the latest technology for portable radios; and

**WHEREAS**, there is a need to increase the spending authority for the contract through the existing term which expires on December 31, 2026; and

**WHEREAS**, this increase in spending authority will allow for the purchase of multi-band portable radios for the Police Department's patrol staff that provide situational awareness and other critical features for efficiency regarding communications; and

**WHEREAS**, Section 2- 585 of the Procurement Code, entitled " Authority" authorizes the City Manager to delegate authority to the Chief Procurement Officer to administer and make recommendations on contract awards;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** The foregoing "**WHEREAS**" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** That the City Commission accepts the recommendation and authorizes the Chief Procurement Officer to increase the NASPO Value Point Contract # 00318 for Public Safety Products, Services and Solutions in an estimated amount of \$4,065,113.19 or in an amount not to exceed the available budget, to purchase next generation portable radios and other related equipment and services pursuant to Section 2- 764(b), Approval of Change Orders and Contract Modifications of the procurement code.


**SECTION 3.** That this Resolution shall become effective upon the date of its passage and adoption herein.
