1. **Chair Gus Perez called the meeting to order at 8:40 a.m.**

2. **Approval of the May 19, 2010 Board Meeting Minutes**

The Board reviewed the Schedule of Outstanding Rents that was provided by the Finance Department as of July 19, 2010.

**5. Additional Business**

Ms. Young asked if there was a judgment against Bijans. Ms. Birdsill stated that there was and the City Attorney's Office is working on collection efforts.

Ms. Young asked about the status of the Biltmore. Ms. Birdsill responded that the Biltmore recently presented the City Commission, at a meeting of the Commission on July 19, 2010, with an interim settlement offer designed to allow the Biltmore to draw on its bank financing. Mr. Perez commented that it sends a bad precedent to the rest of the City tenants for it to allow the Biltmore to be behind in rent payments for such a long period of time.

Ms. Birdsill gave brief updates on the Wine & Fashion Florence Café and the Art Cinema. She also noted that the properties at 4520 Ponce de Leon and 2325 Galiano are receiving considerable interest from prospective tenants.

There was a brief discussion about the importance of Board members attending the meetings and letting the secretary know beforehand if they cannot be present.

There being no further discussion, the meeting was moved to adjourn at 8:57 a.m. by Mr. Mazzei and seconded by Lopez.
