RESOLUTION NO. 2023-67

A RESOLUTION OF THE CITY COMMISSION ACCEPTING A RECOMMENDATION OF THE CITY MANAGER TO WAIVE THE COMPETITIVE PROCESS OF THE PROCUREMENT CODE FOR THE REHABILITATION OF WETWELL COATING FOR PS-A PUMP STATION FROM C&I CONSTRUCTION & DESIGN AS A “SOLE SOURCE PROCUREMENT”, PURSUANT TO SECTION 2-689 OF THE CITY’S PROCUREMENT CODE.

WHEREAS, the Wet Well at PS-A Pump Station, located at 1590 Campamento Avenue, need re-coating due damages caused by sewage gases; and

WHEREAS, per Miami-Dade Water & Sewer Department, all interior concrete surfaces of wet wells shall be coated with the PPC Coating System WW-200-1a/Damp Concrete, as manufactured by Polymorphic Polymers Corporation or approved equal; and

WHEREAS, the estimated cost for this work is \$63,950.00; and

WHEREAS, PPC Coating is the only producer and seller of Polymorphic Polymers Coatings and C&I Construction and Design is South Florida's sole certified applicator; and

WHEREAS, Section 2-689 of the Procurement Code entitled “Sole Source Procurement” authorizes an award without competitive bids when there in only one source available to fulfill the needs of the City; and

WHEREAS, Section 2-585 of the Procurement Code, entitled “Authority” authorizes the City Manager to delegate authority to the Procurement Officer to administer and make recommendations on contract awards;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing “WHEREAS” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.


SECTION 2. That the City Commission accepts a recommendation to waive the competitive process and authorizes the City Manager to award C&I Construction and Design Inc., pursuant to Section 2-689 of the City’s Procurement Code.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.




