RESOLUTION _____

A RESOLUTION ACCEPTING A RECOMMENDATION TO WAIVE THE COMPETITIVE PROCESS OF THE PROCUREMENT CODE FOR THE PURCHASE OF A WASTEWATER PUMP FOR SOLANO PRADO 1 PUMP STATION FROM HYDRA SERVICE INC. AS A “SOLE SOURCE PROCUREMENT”, PURSUANT TO SECTION 2-689 OF THE CITY’S PROCUREMENT CODE.

WHEREAS, the pump at Solano Prado 1 Pump Station needs replacement due to damage resulting from Hurricane Irma; and

WHEREAS, the pump is a component of a larger pump station system that is specifically designed to operate within parameters which are unique to that station; and

WHEREAS, the pump that requires replacement is a 47 HP Sulzer brand and must be replaced in-kind with the same brand; and

WHEREAS, the replacement cost for this pump is \$27,122; and

WHEREAS, any other brand will result in additional cost for design and other changes to the pump station system; and

WHEREAS, Hydra Service, Inc. is the exclusive supplier of Sulzer equipment for the State of Florida; and

WHEREAS, Section 2-689 of the Procurement Code entitled “Sole Source Procurement” authorizes an award without competitive bids when there is only one source available to fulfill the needs of the city; and

WHEREAS, Section 2-585 of the Procurement Code, entitled “Authority” authorizes the City Manager to delegate authority to the Procurement Officer to administer and make recommendations on contract awards.

NOW THEREFORE BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

Section 1. The foregoing “Whereas” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

Section 2. That the City Commission accepts a recommendation to waive the competitive process and authorizes the City Manager to purchase a wastewater pump

for the Solano Prado 1 Pump Station from Hydra Service, Inc., pursuant to Section 2-689 of the City's Procurement Code.

Section 3. That this Resolution shall become effective upon the date of its adoption herein.
