**RESOLUTION NO. 2025-392**

A RESOLUTION OF THE CITY COMMISSION  
AUTHORIZING THE EXECUTION OF A CONTRACT  
WITH FIRE CODE PRO, INC., FOR FIRE PLANS  
REVIEW SERVICES PURSUANT TO SECTION 2-  
607(24) OF THE PROCUREMENT CODE.

**WHEREAS**, the Fire Department desires to execute a professional services agreement (“PSA”) with Fire Code Pro, Inc. for the provision of technical work including the inspection, examination, review, and analysis of plans to ensure compliance with the Florida Building Code, Florida Fire Prevention Code, and other applicable codes and/or regulations governing fire safety; and

**WHEREAS**, this PSA is necessary to ensure the Fire Department has the resources available to cover extended hours of work to ensure continuous service; and

**WHEREAS**, the Fire Department is requesting that the City Commission authorize the City Manager to execute a PSA with Fire Code Pro, Inc., to provide the services, as detailed in PSA 2025-027, with retroactive effect back to October 1, 2025 for a term of no more than one (1) year, and for an annual amount not to exceed \$156,000.00;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** The foregoing “**WHEREAS**” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** That the City Commission authorize the execution of a Professional Services Agreement with Fire Code Pro, Inc., for an amount not to exceed \$156,000.00 during the term of the agreement, pursuant to Section 2-607(24) of the City’s Procurement Code.






