ORDINANCE NO. 2024-34

AN ORDINANCE OF THE CITY OF CORAL GABLES, FLORIDA, AMENDING THE CODE OF THE CITY OF CORAL GABLES, FLORIDA, CHAPTER 2, ENTITLED “ADMINISTRATION,” ARTICLE III “BOARDS, COMMISSIONS, COMMITTEES,” DIVISION 1 “GENERALLY” BY AMENDING SECTION 2-52 “QUALIFICATION AND APPOINTMENT OF MEMBERS” IN ORDER TO OFFER MEMBERS OF CITY BOARDS REDUCED FITNESS MEMBERSHIP FEES AT THE CORAL GABLES WAR MEMORIAL YOUTH CENTER; PROVIDING FOR A REPEALER PROVISION, SEVERABILITY CLAUSE, CODIFICATION, AND AN EFFECTIVE DATE.

WHEREAS, members of City boards and committees freely volunteer their time, efforts, and knowledge for the benefit of the City, its residents, businesses, and stakeholders; and

WHEREAS, in recognition of their contributions, the City currently provides board members with access to the Venetian Pool and certain golf and tennis recreation facilities for free or at a reduced cost during their appointed term through its codified pass policy; and

WHEREAS, the City does not currently offer a benefit for board members at the Coral Gables War Memorial Youth Center, which is a City facility that features an indoor fitness center, gymnasium, and basketball courts; and

WHEREAS, in order to provide additional recreation options for board members who may not swim, play tennis or golf, the Commission desires to expand its pass policy to offer a reduced rate on fitness memberships at the Coral Gables War Memorial Youth Center;

NOW, THEREFORE, BE IT ORDAINED BY THE COMMISSION OF THE CITY OF CORAL GABLES, FLORIDA:

SECTION 1. That the foregoing “**WHEREAS**” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Ordinance upon adoption hereof

SECTION 2. That Chapter 2 – ADMINISTRATION of the City of Coral Gables City Code be amended as indicated in the attached Exhibit A:

SECTION 3. All Ordinances or parts of Ordinances inconsistent or in conflict with the provisions of this Ordinance are hereby repealed.

SECTION 4. If any section, part of section, paragraph, clause, phrase or word of this Ordinance is declared invalid, the remaining provisions of this Ordinance shall not be affected.

SECTION 5. It is the intention of the Commission of the City of Coral Gables, Florida, that the provisions of this Ordinance shall become and be made part of the City of Coral Gables City Code and that the sections of this “Ordinance” may be changed to “section”, “article”, or such other appropriate word or phrase in order to accomplish such intentions.

SECTION 6. If the City of Coral Gables City Code Table of Contents or other reference portions is affected by these provisions, then changes are approved as a part of this Ordinance.

SECTION 7. This Ordinance shall become effective upon its passage and adoption herein.





- (h) *Pass policy.* Each board member shall be issued an identification card by the city clerk, which may be used at city recreation facilities during the appointed term only, as hereinafter set forth:
- (1) Biltmore/Granada golf (green fees only):
 - a. Monday through Friday: no charge.
 - b. Saturday, Sunday and holidays: twilight fee before 12:00 noon, no charge after 12:00 noon.
 - (2) Biltmore/Salvadore tennis: Monday through Sunday, including holidays, no charge.
 - (3) Venetian pool: Monday through Sunday, no charge.
 - (4) Coral Gables War Memorial Youth Center: 50% off the applicable resident rate for any fitness membership
