**RESOLUTION NO. 2023-16**

A RESOLUTION OF THE CITY COMMISSION AUTHORIZING MAYOR LAGO TO SEND A FORMAL LETTER TO MIAMI-DADE COUNTY MAYOR LEVINE CAVA REGARDING SEVERAL PUBLIC WORKS PENDING REQUESTS WHICH REQUIRE ACTION OR APPROVAL FROM MIAMI-DADE COUNTY.

**WHEREAS**, the City Commission finds that several Public Works requests submitted by the City to Miami-Dade County remain pending and/or unaddressed; and

**WHEREAS**, these requests include, but are not limited to, requests for maintenance of five county owned bridges, maintenance under the Metrorail in the Underline development area, replacement of outdated and worn signage throughout the city, milling and resurfacing of County-maintained roadways, signalization or intersection improvements at key intersections, requests for crosswalks and traffic calming; and

**WHEREAS**, the City of Coral Gables is a full service city that contributes over one hundred million dollars to Miami-Dade County through property taxes; and

**WHEREAS**, the City Commission seeks to expedite the Resolution of these ongoing, and in some cases long-standing, service requests for the benefit of the community; and

**WHEREAS**, the letter will serve to inform the Miami-Dade County Mayor and request her support in resolving these requests;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** The foregoing "**WHEREAS**" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.


**SECTION 2.** That the City Commission hereby authorizes Mayor Lago to send a formal letter to Miami-Dade County Mayor Levine Cava regarding several Public Works pending requests which require action or approval from Miami-Dade County.

**SECTION 3.** That this Resolution shall become effective upon the date of its passage and adoption herein.




