The main emphasis was on the design, keeping the original turtle (which was sold to a neighbor by the City of Coral Gables.) W We had a couple of very well attended and spirited meetings and all the neighbors were in agreement it would be a passive park for children to play. Never were dogs mentioned in the initial plan. My husband and I own two dogs so it is not about the fact that people do not like dogs.

The problem is the people who have been coming to the park. No rules are followed, large dogs, small dogs, all sizes of dogs are being brought by their owners to the park. The rule clearly says that dogs are to be on a leash. Dogs are not put on a leash.
