RESOLUTION NO. 2026-201

A RESOLUTION OF THE CITY COMMISSION SETTING THE PROPOSED OPERATING MILLAGE RATE OF 5.559 FOR THE FISCAL YEAR 2026-2027; TO BE SUBMITTED TO THE MIAMI-DADE COUNTY PROPERTY APPRAISER IN THE FORM REQUIRED BY SECTION 200.065, FLORIDA STATUTES.

WHEREAS, Florida Statutes, Chapter 200 establishes August 4th as the annual certification date for municipalities to set a tentative operating millage rate; and

WHEREAS, in compliance with Article V of the City Charter, the City Manager prepared the Fiscal Year 2026-2027 Budget Estimate for submission to the City Commission on July 1, 2026; and

WHEREAS, the City Manager provided a presentation on the Fiscal Year 2026-2027 Budget Estimate to the City Commission at a Budget Meeting held on Wednesday, July 8, 2026, at 9:00 AM; and

WHEREAS, in the Fiscal Year 2026-2027 Budget Estimate, the City Manager recommended an Operating Millage rate of 5.559 mills;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. That the foregoing “**WHEREAS**” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution upon adoption hereof.

SECTION 2. That a Millage Rate of 5.559 mills is hereby passed and adopted as the Proposed Operating Millage for the Fiscal Year commencing October 1, 2026, and ending September 30, 2027.

SECTION 3. That as required by Florida Statutes, Chapter 200, the Finance Director is hereby directed to file the tentative operating millage with the Miami-Dade Property Appraiser by August 4, 2026.

SECTION 4. That this Resolution shall become effective immediately upon the date of the passage and adoption herein.

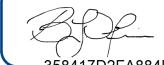
