ITEM TITLE:

Resolution approving a Memorandum of Understanding between the City of Coral Gables and University of Miami Police Department for University of Miami Police Department to join the City's fiber Institutional Network operations.

RECOMMENDATION OF THE CITY MANAGER:

Approval

BRIEF HISTORY:

By Ordinance No. 3278, passed in October 1997, and by Ordinance 2004-50, passed in December 2004, the City has established a cable television franchise agreement whereby all governmental authorities, schools, or persons designated by the City are interconnected by an Institutional Network (I-Net.)

The University of Miami Police Department (UMPD) is one of those locations identified to be connected to the I-Net. UMPD is a public safety organization operating as a sub-agency to the City of Coral Gables Police Department (CGPD). As such this connection to the I-Net is considered a special public safety connection in support of mission-critical applications such as Computer Aided Dispatch (CAD) and Records Management System (RMS). This special I-Net connection to the CGPD public safety network, called a PS-Net, provides UMPD with a high speed connection, dramatically increasing speed and reliability. The connection further increases productivity for UMPD staff enabling them to provide enhanced services to campus personnel, staff and the student body.

UMPD intends to use the PS-Net connection for Public Safety and institutional purposes and agrees that they will comply with the terms and conditions of the MOU for a three-year term.

The City will provide UMPD with a high speed connection through the PS-Net shared fiber network. The fiber that provides the PS-Net connectivity was installed and is operated and maintained at the sole expense of the cable television franchisee. The electronics that will be used to provide the connectivity at the UMPD location will be purchased, installed, and maintained by the City. UMPD will compensate the City for all equipment, connection, installation and maintenance with payments of \$365 per month for a three (3) year period at a sum of \$13,140.
