A RESOLUTION ACCEPTING THE BID OF WILCO ELECTRICAL, LLC, AS BEING THE LOWEST AND MOST RESPONSIVE, RESPONSIBLE BID IN THE SUM OF \$72,592.00, FOR THE UPGRADING OF ELECTRICAL SERVICE AT SALVADORE TENNIS CENTER, CORAL GABLES, FLORIDA.

SECTION 1. The foregoing "Whereas" clause is hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution upon adoption hereof.

SECTION 2. That the City Commission does hereby authorize the City Manager to accept the bid of Wilco Electrical, LLC for the upgrading of electric service at Salvadore Tennis Center, Coral Gables, Florida, in the sum of \$72,592.00.

SECTION 3. That said bid has been recommended by the Public Works Department as being the lowest responsive, responsible bid from among the aforementioned bids opened on August 5, 2008.

SECTION 4. That the City Commission does hereby instruct the City Manager to direct the Finance Director to allocate the necessary funds and to charge this project to the Miami-Dade General Obligation Bond.

SECTION 5. That this Resolution shall become effective upon the date of its passage and adoption herein.
