RESOLUTION NO. 2022-37

A RESOLUTION OF THE CITY COMMISSION AUTHORIZING THE CITY MANAGER TO EXTEND A MAINTENANCE AND SERVICE AGREEMENT IN PARKING GARAGES 2, 4, AND 6 WITH WPS USA CORP. FOR MAINTENANCE AND SERVICE OF THE PARKING AND REVENUE CONTROL EQUIPMENT AND CONSOLIDATE THE START AND END DATES OF PARKING GARAGES 1, 2, 4, AND 6 MAINTENANCE AGREEMENTS.

WHEREAS, the PARCs system is used to manage traffic and transactions in the City’s four public parking garages; and

WHEREAS, the PARCs system manages more than 1,000,000 transactions annually in the City parking garages with a total value of nearly \$4,000,000; and

WHEREAS, the City purchased and installed a new parking and revenue control system (PARCs) in Garages 2 and 6 in 2015, Garage 1 in 2017 and Garage 4 in 2018 from WPS; and

WHEREAS, the initial maintenance and service agreement is set to expire in 2022 for Garages 2 and 6 in 2023 for Garage 1, and in 2024 for Garage 4; and

WHEREAS; the City of Coral Gables would like to extend the current maintenance and service arrangement with WPS through 2024 and consolidate the end dates of the service agreements in the four parking garages;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The forgoing “Whereas” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption herein; and


SECTION 2. That the City Manager is authorized to enter into an extension of the maintenance and service agreement with WPS covering the PARCs equipment installed in the City Parking Garages 2, 4, and 6, in a form substantially like the draft agreement attached that is mutually acceptable to the City Manager and City Attorney, and which reflects the intention of the Commission stated herein.

SECTION 3. That total cost of the maintenance and service agreement for Garages 2, 4, and 6 for 2023 will be Sixty-Four Thousand Seven Hundred Forty-Eight Dollars (\$64,748); for 2024 will be Sixty-Five Thousand Seven Hundred Twenty-Six Dollars (\$65,726).


SECTION 4. That this Resolution shall become effective upon the date its passage and adoption herein.
