ACTION/RECOMMENDATION:

Request a Sole Source Authorization to Communications International for the purpose of renewing a L3 Harris software services maintenance agreement for the Coral Gables P25 Public Safety Radio System.

BACKGROUND:

The Coral Gables P25 radio system is a mission critical communications infrastructure built with L3HARRIS licensed server operating system software and proprietary dispatch user interface software. The software runs on the following platforms located at the following:

- Police and Fire Headquarters – 4th Floor Dispatch Center (Dispatch Consoles) – Nineteen 911 Radio Dispatch Symphony Consoles with Windows 10 LTSC and L3 Harris proprietary dispatching software.
- Police and Fire Headquarters – 3rd Floor (Radio System Core) – A Dell hardware server system with twenty-two Windows Server 2016 and Red Had Linux Server virtual machines also running L3 Harris proprietary software as part of the radio system backbone.
- Trolley Depot Building – 2nd Floor Backup PSAP (Dispatch Consoles) – Five 911 Radio Dispatch Symphony Consoles with Windows 10 LTSC and L3 Harris proprietary dispatching software.
- Regions Bank Radio Site (Radio System Core) - A Dell hardware server system with eight Windows Server 2016 and Red Had Linux Server virtual machines also running L3 Harris proprietary software as a redundant live switching server backup for the radio system backbone.
- UMPD Dispatch Center (Dispatch Consoles) - Two 911 Radio Dispatch Symphony Consoles with Windows 10 LTSC and L3 Harris proprietary dispatching software.

As to ensure network security across radio system equipment, it is necessary to renew the L3HARRIS (SUMS) Security Update and Software Update Managed Services along with the annual technical support priority call center services. The software updates and network security patches are tested at the factory before implementing a live public safety communications system. The L3HARRIS TAC support call center provides radio system technical support and online website access to technical manuals along with hardware software code updates for radio equipment. L3HARRIS is a communications equipment manufacturer and provides government sector sales and service through assigned regional representatives. Communications International is our assigned L3Harris representative; therefore, Communications International is the single source for L3Harris equipment purchases and annual software services renewals.

SYNOPSIS/CONCLUSION:

The annual renewal cost for software services for this billing cycle is \$160,109 and funding is available from the TSD software maintenance account # 001-5030-521-5401. The cost of this procurement is above \$25,000 cap and will require city commission approval.
