A RESOLUTION OF THE CITY COMMISSION OF CORAL GABLES AMENDING RESOLUTION NO. 2013-89, KNOWN AS THE FEE RESOLUTION, BY AMENDING THE LOW VOLTAGE BURGLAR ALARM SYSTEMS PERMIT FEE TO COMPLY WITH THE 2013 FLORIDA STATUTES; AND PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS**, Resolution No. 2006-187, passed and adopted by the City Commission on October 10, 2006 and subsequently amended by Resolution 2006-211 on December 12, 2006; Resolution 2007-153 on June 26, 2007; Resolution 2007-245 on October 23, 2007; Resolution 2008-201 (As Amended) on November 18, 2008; Resolution 2009-195 on July 7, 2009; Resolution 2009-218 on July 29, 2009; Resolution 2009-233 on August 25, 2009; Resolution 2010-132 on July 13, 2010; Resolution 2010-184 on August 24, 2010; 2011-170 on July 19, 2011, Resolution 2011-2013 on August 23, 2011, and Resolution 2013-89 on May 28, 2013, established fees for various licenses, permits, services and penalties by the City of Coral Gables; and

**WHEREAS**, the Florida Statutes was amended in 2013 that reduced the cost for the low-voltage alarm system permit fee to \$55.00; and

**WHEREAS**, it necessary to amend the City's fee schedule to comply with the Florida Statutes; and

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** The fee schedule beginning on page 53 of 101 in Resolution No. 2013-89 is hereby amended to include the following changes (changes in ~~strike-through~~ / underline format):
