DRAFT RESOLUTION _____

A RESOLUTION ACCEPTING THE RECOMMENDATION OF THE CHIEF PROCUREMENT OFFICER TO EXTEND THE LANDSCAPE ARCHITECT CONSULTING SERVICES CONTINUING CONTRACTS WITH CURTIS + ROGERS DESIGN STUDIO, INC., AND GEOMANTIC DESIGNS, INC. PURSUANT TO SECTION 2-829 OF THE PROCUREMENT CODE ENTITLED “APPROVAL OF CHANGE ORDERS AND CONTRACT MODIFICATIONS”, UNTIL JULY 8, 2016, WITH EXTENSIONS AT THREE (3) MONTHS INTERVALS AS NEEDED THEREAFTER UNTIL AN UPDATED SCOPE OF SERVICES IS PROVIDED TO PROCUREMENT, A NEW RFQ PROCESS IS COMPLETED, AND NEW CONTRACTS ARE EXECUTED.

WHEREAS, on February 28, 2012, the City Commission approved continuing contracts for landscape architect consulting services as the result of a Request for Qualifications (RFQ) process; and

WHEREAS, the purpose of the continuing contracts are to provide landscape architect consulting services necessary in the areas of planning, design, analysis, cost estimating and surveying; and

WHEREAS, the current contract with Curtis + Rogers Design Studio, Inc. expires on May 8, 2016, and contract with Geomantic Designs, Inc. expires on April 2, 2016; and

WHEREAS, in order to allow time for the revised scope of services to be provided, for the RFQ process to be completed, for new contracts to be approved, and to authorize extensions of the existing continuing contracts, it is recommended that the Landscape Architect Consulting contracts be extended until July 8, 2016, and as needed in three (3) month intervals; and

WHEREAS, Section 2-650 of the Procurement Code authorizes the City Manager to delegate authority to the Chief Procurement Officer to administer and make recommendations on City contracts; and

WHEREAS, the contracts with Curtis + Rogers Design Studio, Inc. and Geomantic Designs, Inc. may be extended under Section 2-829 of the Procurement Code entitled “Approval of Change Orders and Contract Modifications”.

NOW THEREFORE BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

Section 1. The foregoing “Whereas” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

Section 2. That the City Commission accept the recommendation of the Chief Procurement Officer to extend the Landscape Architect Consulting Services continuing contracts with Curtis +

Rogers Design Studio, Inc., and Geomantic Designs, Inc. pursuant to Section 2-829 of the Procurement Code entitled "Approval of Change Orders and Contract Modifications", until July 8, 2016, with extensions at three (3) months intervals as needed thereafter until an updated scope of services is provided to Procurement, a new RFQ process is completed, and new contracts are executed.

Section 3. That the City Commission does hereby authorize the City Manager to execute an extension of the Contract with such modifications to the form attached hereto as Exhibit "A" as may be approved by the City Manager and City Attorney that are necessary to implement the intent of this Resolution.

Section 4. That this Resolution shall become effective upon the date of its adoption herein.
