Notice is hereby given that F. W. Zeke Guilford, Esq., the applicant, has filed an Appeal to the Coral Gables City Commission, from a decision of the Historic Preservation Board at its regular meeting held on Thursday, June 16, 2016 to designate the property located at 229 Ridgewood Road, legally described as Lots 9 and 10, Block 2, Coconut Grove Manor, according to the Plat thereof, as recorded in Plat Book 17, at Page 19 of the Public Records of Miami-Dade County, Florida as a Local Historic Landmark, thereby listing it on the Coral Gables Register of Historic Places.

CASE FILE LHD 2016-08: The applicant is appealing the decision of the Historic Preservation Board ruling designating property located at 229 Ridgewood Road, Coral Gables, Florida 33133, a Local Historic Landmark to be placed on the Coral Gables Register of Historic Places.

The City of Coral Gables Commission will consider said appeal at its regular Commission Meeting on Tuesday, August 23, 2016, beginning 9 A.M., in City Hall Commission Chambers, located at 405 Biltmore Way, wherein all interested persons may be heard. Said appeal may be inspected at the Office of the City Clerk.

Pursuant to Section 286.0105, Florida Statutes (2016), anyone wishing to appeal any decision made by the City Commission shall be required to ensure that a verbatim record of the proceedings is made, including all testimony and evidence upon which an appeal may be based.
