Budget Director Kleiman: Good afternoon again Commission. So, I'd like to read it into the record. This item has two components to it. The first is an increase to the BTR, the Business Tax Receipts.

City Commission Meeting

The State Legislature authorize municipalities to increase local business tax rates by a maximum of five percent, once every two years as provided under Chapter 205.0535 of the Florida Statutes. Since the adoption of this legislation, the City of Coral Gables has increased local business tax rates every two years as authorized. The attached resolution increases each classification by five percent, effective for the July 1, 2021, beginning of Fiscal Year 22 Business Tax Receipts. The amended local business tax rates will adjust the annual revenue by approximately \$167,500. The second part of this is Park Fees. The Park Fees schedule is based on a five-year fee plan. Due to the pandemic the increase that would have been implemented last year did not occur. The new proposed fee plan will continue the five-year plan and, in most cases, fees are increased five percent every other year. There is a typographical error in the fee structure that was sent out, it has been corrected and submitted to the Clerk's office. Any questions. Fred is here to discuss the parks. I can talk about the BTR's.
