ITEM TITLE:

Board of Adjustment Appeal – Application No. VARI-23-04-0008 (10 Edgewater Drive).

Glen Larson/Dock and Marine Construction, applicant, has filed an appeal to the Coral Gables City Commission, from a decision of the Board of Adjustment at its regular meeting of Monday, June 5, 2023, wherein it denied the following variance request as outlined under the applicant's proposal.

SUMMARY OF APPEAL:

Glen Larson/Dock and Marine Construction, applicant, (the appellant) has filed an appeal to the Coral Gables City Commission, from a decision of the Board of Adjustment at its regular meeting of Monday, June 5, 2023, wherein it denied the application for a variance to allow a boatlift to extend thirty-three feet and ten inches (33'-10") from the bank of the waterway vs. watercraft lifts or floating watercraft lifts shall not extend beyond twenty-five feet (25') from the banks of waterways, pursuant to Section 3-705(E) of the Coral Gables Zoning Code.

The transcripts for the June 5, 2023 Board of Adjustment meeting is attached as Exhibits C. The applicant presented the item, staff recommended denial and the Board voted (6-0) to deny the variance request.
