A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE RECOMMENDATION OF THE PROCUREMENT OFFICER TO AWARD THE SANITARY SEWER CLEANING AND CCTV CONTRACT TO UIT, LLC., THE LOWEST RESPONSIVE AND RESPONSIBLE BIDDER, IN THE ESTIMATED INITIAL AMOUNT OF \$160,950 FOR THE INITIAL TWO (2) YEAR TERM WITH THREE (3) ONE (1) YEAR RENEWALS, PURSUANT TO INVITATION TO BIDS (IFB) 2019-026 AND SECTION 2-763 OF THE CITY'S PROCUREMENT CODE ENTITLED "CONTRACT AWARD".

WHEREAS, on October 7, 2019, the Procurement Division of Finance formally advertised, issued and distributed the IFB for the Sanitary Sewer Cleaning and CCTV.; and

WHEREAS, on November 6, 2019, five (5) bids were received in response to the IFB 2019-026 from: Altair Environmental Group, LLC., Hinterland Group, Inc., National Water Main Cleaning Company, Shenandoah General Construction Company, and UIT, LLC.; and

WHEREAS, the Public Works Department concurs with the Procurement Officer's recommendation to award the Sanitary Sewer Cleaning and CCTV contract to UIT, LLC.; and

WHEREAS, Section 2-585 of the Procurement Code, entitled "Authority" authorizes the City Manager to delegate authority to the Procurement Officer to administer and make recommendations on contract awards;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Commission accepts the recommendation of the Procurement Officer and authorizes the City Manager award the Sanitary Sewer Cleaning and CCTV contract to UIT, LLC., the lowest responsive and responsible bidder in the initial estimated amount of \$160,950.00 for the initial two (2) year term with three (3) one (1) year renewals, pursuant to Invitation for Bids (IFB) 2019-026 and section 2-763 of the procurement code entitled "contract award".

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.
