RESOLUTION NO. 2026-47

A RESOLUTION OF THE CITY COMMISSION GRANTING PERMISSION TO THE CITY CLERK TO PROCEED WITH PREPARATION OF THE MUNICIPAL ELECTION ORDER FORM IN CONJUNCTION WITH THE MIAMI DADE COUNTY SUPERVISOR OF ELECTIONS FOR SERVICES, MATERIALS AND SUPPORT TO BE RENDERED, IN CONNECTION WITH THE CORAL GABLES SPECIAL MAIL BALLOT ELECTION OF APRIL 21, 2026, TO PROCURE THE NECESSARY BALLOTS AND OTHER FORMS, TO ASSIST IN ALL ASPECTS OF THE SPECIAL MAIL BALLOT ELECTION AND CANVASS OF RETURNS FROM OUR DESIGNATED PRECINCTS WITHIN THE CITY OF CORAL GABLES.

WHEREAS, pursuant to the Florida Elections Code, the Miami-Dade County Supervisor of Elections follows State law in connection with printing of ballots and other necessary forms (Sections 101.21 and 101.24 of the Florida Statutes), appropriate procedure for the canvass of returns from the precincts (Section 101.5614 of the Florida Statutes) in its elections process, as well as implementation of mail ballot elections prescribed by Section 101.6101-6017, Florida Statutes; and

WHEREAS, in making the necessary preparations for the upcoming April 21, 2026, Special Mail Ballot Election of Coral Gables, the City Clerk is desirous of proceeding with preparation of the Municipal Election Order form, in conjunction with the Miami-Dade County Supervisor of Elections for services, materials and support to be rendered, in connection with the below referenced services; and

WHEREAS, the Miami-Dade County Supervisor of Elections has consented to conduct said elections, as more fully articulated in the attached listing of services (; ballot shipping; postage charges; ballot creation; ballot printing/tabulation; iVotronic sound files; election technical support; election specialist telephone charges, etc.) to be rendered, per attached Municipal Election Order Form;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing “**WHEREAS**” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this resolution upon adoption hereof.

SECTION 2. That the City Clerk is hereby instructed to proceed with preparation of the Municipal Election Order Form for services, materials, and support in connection with the upcoming Special Mail Ballot Election of April 21, 2026.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.


