Clearly, George Merrick considered tile roofs as a major defining feature of Coral Gables. While metal roofs may be acceptable in areas of the Gables that were not developed in the 1920-30s, they are decidedly not appropriate in the areas north of Dixie Highway where most of the historic homes are located. Just the thought of a metal roof on a street that has a large number of historic, red, barrel tile roofs is very troubling. After the City of Coral Gables abandoned the Mediterranean requirement post World War II, many white tile roofs appeared on homes. Although different from the original red barrel tile, the tile requirement remained. Between 1945 and 1973 people tried to modernize or "de-rMediterraneanize" their homes—removing red barrel tile, covering up coral rock, and adding awning windows. Fortunately, the City of Coral Gables through the county's first preservation ordinance raised the consciousness</p>

I understand that you were not part of placing the roof matter on the agenda and that it is too late for the matter to be before the commission on April 8 as a proposed ordinance. However, you should also see that what I was telling you was accurate. Attached please find an excerpt of the PZB package (from staff) that includes a proposed ordinance. Note that the proposed ordinance states that the matter is before the commission on first reading on April 8, 2008 (apparently not any longer).
