RESOLUTION NO. 2017-328

A RESOLUTION ACCEPTING THE RECOMMENDATION OF THE PROCUREMENT OFFICER TO AUTHORIZE THE PURCHASE OF RESURFACING SERVICES TO VARIOUS SALVADORE PARK-TENNIS CENTER CLAY COURTS FROM FAST-DRY COURTS AS A SPECIAL PROCUREMENT/BID WAIVER, IN AN APPROXIMATE AMOUNT OF \$99,700.00, PURSUANT TO SECTION 2-772 OF THE CITY'S PROCUREMENT CODE.

WHEREAS, the City's Parks and Recreation Department is responsible for maintaining the Salvadore Park-Tennis Center; and

WHEREAS, various clay tennis courts suffered a significant loss of clay court material due to Hurricane Irma that reduced the minimum level of surface material required to maintain court safety and the Standards of Court Builders Association/USTA; and

WHEREAS, due to the unsafe condition of the courts that has rendered them unusable by Coral Gables residents and unusable for the upcoming Junior Orange Bowl Championships that are scheduled to take place in early December 2017; and

WHEREAS, Fast-Dry Courts is qualified and available to perform the services to restore the clay courts based on work previously performed at the location; and

WHEREAS, Section 2-772 of the Procurement Code entitled "Special Procurement/Bid Waiver" authorizes the Procurement Officer to initiate a special procurement/bid waiver when an unusual or unique situation exists that makes the application of all requirements of competitive sealed bidding or competitive sealed proposal contrary to the public interest; and

WHEREAS, Section 2-650 of the Procurement Code, entitled "Authority" authorizes the City Manager to delegate authority to the Procurement Officer to administer and make recommendations on contract awards;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Commission accepts the recommendation of the Procurement Officer to authorize the purchase of resurfacing services for Salvadore Park Tennis Courts from Fast-Dry Courts, in the approximate amount of \$99,700, pursuant to Section 2-772 of the City's Procurement Code.

SECTION 3. That this Resolution shall become effective upon the date of its adoption herein.
