## RESOLUTION NO. 2022-159

A RESOLUTION OF THE CITY COMMISSION AMENDING ORDINANCE NO. 2015-17, AS AMENDED, TO REVISE VARIOUS FIRE PREVENTION PERMIT FEES AND SOLID WASTE COLLECTION SPECIAL PICK-UP FEES; PROVIDING FOR SEVERABILITY, AND AN EFFECTIVE DATE.

**WHEREAS**, the City Commission desires to make changes to the Fee Schedule to update its various Solid Waste Collection Special Pick-Up services;

## NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

- **SECTION 1.** The foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.
- **SECTION 2.** The City Commission revises the Fee Schedule as detailed in Exhibit B, with changes indicated by <u>underline</u> for new text and <u>strikethrough</u> for deleted text.
- **SECTION 3. SEVERABILITY**. If any section, sentence, clause of phrase of this Resolution is held to be invalid or unconstitutional by any court of competent jurisdiction, then said holding shall in no way affect the validity of the remaining portions of this Resolution.

**SECTION 4. EFFECTIVE DATE**. This Resolution shall become effective October 1, 2022.
