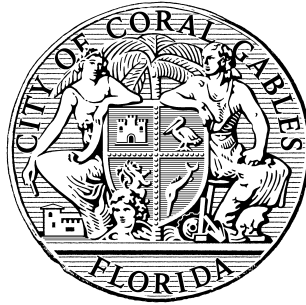

[Note for the Record: Mayor Slesnick requested of City Manager to address Agenda Item C-1, whereby Mr. Salerno instructed Chief Naue to introduce the Officer of the Month Award for the Month of October, namely Officer Kimberly DiGiacomo; further stating that Officer Digiacoamo was nominated for said honor for her investigation that resulted in the arrest of an offender that was charged with two counts of Occupied Burglary and 2 Counts of Video Voyeurism and one count of filing a false police report; further noting that on August 15, 2010 Officer DiGiacomo was dispatched to investigate a call on 9380 Balada Street in connection with an incident wherein an unknown subject was seen photographing homeowner's juvenile daughter while she was undressing in her bedroom; upon arriving at the location in question, Officer DiaGiacomo conducted a preliminary investigation of the incident and found out that the juvenile's bedroom was not visibly accessible unless the subject entered the cartilage of the residence.

Following interviews with the victim, her family members and guests whom were present at the residence, said victim relayed to Officer DiGiacomo that the subject photographed her while she was nude, by using a new iPhone. Officer DiGiacomo reported the incident to Wackenhut Security Guard Eric Owens who informed Officer DiGiacomo that while patrolling nearby, he pursued a subject on foot that was looking at cars; further stating that he chased the subject into the victim's residence.

The homeowner of said location contacted the Coral Gables Police Department's Communications Dispatcher and inquired if there was a logged call received from a security guard of an incident that occurred at her residence, whereby she was informed that there were no records of anyone requesting to dispatch a police unit to her residence.

The investigative information supplied by Officer DiGiacomo describes a very nervous Wackenhut Security Guard Eric Owens. Officer DiGiacomo further stated that she had interviewed a female security guard, who also corroborated the fact that Mr. Owens had returned to the guard, appearing sweaty and informing her that he had observed a suspect filming the victim through the bedroom window and that he had chased him; further stating that she had inquired whether Mr. Owens owns an iPhone?-whereby the female security guard acknowledged same, more specifically one of the newer models, adding that she had discussed his ownership of an iPhone previously with him; further informing Officer DiGiacomo that she also is an employee of AT&T.

Officer DiGiacomo acknowledged the involvement of other officers that she delegated various duties (i.e. Officer J. Estevez- task of interacting with Mr. Owens to obtain further investigative information; Officer Poole- process crime scenes and collect information related to the incident; Officers Rubido and Coleman- canvassing the area to locate the iPhone; Officer Jenkins- who was summoned to the area because of her familiarity with the iPhone and its application, etc.)

Through the assistance of Officers Rubido and Coleman, along with Officer DiGiacomo, the iPhone was discovered where Mr. Owens had parked his Wackenhut Security vehicle; said phone appeared to match the description given by the juvenile that was used to photograph her nude in her bedroom.

Officer later convinced Mr. Owens to voluntarily come to the police station wherein he admitted to photographing the juvenile female; he was later placed under the arrest and charged with two counts of burglary; two counts of video voyeurism and filing a false police report to a law enforcement officer.

Chief Naue further stated that due to Officer DiGiacomo's persistency and self-determination, that Mr. Owens is no longer roving in a community to commit further criminal activity.

In accepting this accolade, Officer DiGiacomo stated that she is honored; further thanking the selection committee for nominating her; further adding that she is very happy to have been able to deal apprehending this criminal activity].

[Note for the Record: Mayor Slesnick prefaced his remarks by noting that it has been a tradition in Coral Gables to honor those individuals in our community, as well as pay homage to those ideas and programs that the City has participated in; further noting that the City of Coral Gables was first declared a “Playful City” during a period of time when our City was facing an economic downturn; further referencing a letter that was received from a resident wherein said individual questioned the appropriateness of our City becoming a “Playful City;” further pointing out that if our City does not become a “Playful City,” then we are heading toward a state of depression; further reminding the viewing public that a “Playful City” is about our City’s Recreation Department, further pointing out the efforts of certain Commissioners Withers and Cabrera, respectively in coaching kids in various sports (i.e. basketball and football); further noting that becoming a “Playful City” is critical to our welfare and to childhood obesity; further stating that because of our facilities-Youth Center; golf courses, tennis courts, play spaces, we have been designated a “Playful City” and on November 6th, 2010; further stating we will be having a “Play Day”-a time to celebrate our youth to go out and play, a time for getting out and getting healthy; whereby Mayor Slesnick read into the public record a proclamation declaring November 6th, 2010 as “Playful City USA Day.”

Parks and Recreation Department Director Fred Couceyro stated that there will be activities and games for all ages; interactions with families; further acknowledging the role of KaBoom in trying to obtain opportunities for kids to commit to playful activities, along with providing facilities and programs for kids to enjoy play spaces and enjoy themselves].

[Note for the Record: Commissioner Maria Anderson introduced Alyssa Mayer, Community Representative of the American Cancer Society, to discuss the Relay for Life of Coral Gables event scheduled to take place in Merrick Park, April 16-17, 2011. This event represents an 18 hour journey, which has been described as providing the light of day and the dark of night to parallel the physical ordeal, emotions and mental state of a cancer patient while undergoing treatment.

Ms. Mayer informed the viewing audience that said event celebrates the lives of people who have battled cancer, it remembers loved ones lost to the disease, as well as those who have fought back, having been touched by cancer and who want to put an end to the disease.

Ms. Mayer stated that the co-chairpersons for the upcoming event are Commissioner Maria Anderson and Sarah Artecona, and that Mayor Slesnick will serve as the Honorary Chairman. The events include a Survivor’s Lap (which symbolizes the courage that cancer survivors and their families display every day) along with the Opening Ceremony and the Luminaria Ceremony (i.e. glowing bags that appear to be simply paper sacks filled with sand and candles, but every bags represents a life that has battled cancer). Ms. Mayer further explained that because cancer never sleeps, each team is asked to have a representative on the track at all times during the

overnight event.

Ms. Mayer stated that there will be a reception in connection with the “Relay for Life of Coral Gables,” which is scheduled for October 26, 2010, starting at 7:00 p.m., at 2100 Ponce de Leon Boulevard, in Coral Gables.

Questions, Answers, Inquiries and Concerns from the City Commission: Commissioner Withers inquired as to whether the “Relay for Life” organizers are taking in any new ideas for other events?- further mentioning the Waterway Renaissance Group that is reclaiming the waterways in Coral Gables, and its representative, Peter Hairston; further pointing out that they have canoes, paddleboats, kyaks, etc., and that maybe consideration for a regatta type event would be huge for awareness. Commissioner Anderson added that the City can provide her with contact information regarding same].

[Note for the Record: Immediately following the roll call on Agenda Items E-1 and E-2, Mayor Slesnick requested of those individuals exiting the City Commission Chambers to remain inside the Chambers for approximately three minutes longer, for an important announcement that will be very important to the future of our City, thereby requesting of City Attorney Hernandez to address the dais. Ms. Hernandez recalled that she began representing the City during Calendar Year 1985, before finally serving as the City Attorney in January of 1995; further recalling that she has watched her children grow up in the City Hall; as well as watching her city grow up as well, from a sleepy district to a vibrant metropolis; further stated that she has been a proud and dedicated public servant who longs for the preservation of Home Rule and the Coral Gables way of life, which she describes as one of the most beautiful cities in the nation, a model for other cities to emulate.

City Attorney Hernandez pointed out that she has collected great memories during her tenure-noting the Police Department description of her as a “great cop wanna-be;” further recalling that former Police Chief Harley anointed her as “Police Chief for a Day,” before demoting her by day’s end; that the late Police Chief Michael Hammerschmidt gave her a blue light which she maintains in the back of her car, regarding said apparatus, she assures City Manager Salerno that she will return same; further informing the City Commission and the viewing public that she has been presented with a new career opportunity, and has decided to accept same, and will retire effective December 31st, 2010 on the anniversary month of her 16 years of service with the City. In looking ahead toward departure, Ms. Hernandez thank the City Commission for everything, and for all of the great memories.

University of Miami President Donna Shalala thanked City Attorney Hernandez for her thoughtful leadership, and great friendship noting that she has been a tough attorney who has represented the City and its residents’ well. Jeffrey Bass, Esquire, counsel representing the University of Miami echoed the same sentiments given by President Shalala, and wished her well.

Mayor Slesnick conveyed to Ms. Hernandez that he knows that the City Commission will be reaching out to her leading up to her departure to thank her for her 16 years of service; further instructing the City Clerk to work with him in crafting an appropriate Resolution/protocol document for her December 31st send-off; further requesting of the City Manager to allow the City Commission to use the Human Resources Department to work with the City Commission in furtherance of the recruitment effort of a City Attorney.

City Manager Salerno stated that it is his job to supervise the Department heads and

provide direction to them. Mayor Slesnick clarified that what he is requesting is something desired by the City Commission in furtherance of recruitment for the position of City Attorney-and that is informing them as to how we will reach out in furtherance of said recruitment effort, what the notice is going to say, etc.

Commission Withers reminded his colleagues that at the appropriate time, that he would like to consider for discussion the matter of outsourcing of the Office of the City Attorney, as an option; further commending Ms. Hernandez on being more than just a City Attorney, but an ambassador, who has embraced the social aspect; further citing her awards and recognitions, her character, networking efforts, etc.; further expressing curiosity as to what she will be doing in the future.

City Commissioner Anderson suggested that it would be appropriate to discuss said outsourcing option at another time; further expressing her gratitude to Liz that she is doing something that she wants to do for herself and for her family; further stating that ultimately, that is what is important.

Vice Mayor Kerdyk stated that it is nice to leave at the top of one's game; further citing her recent legal success on behalf of the City (i.e. Kuvins Case, Academica, etc.); further wishing her the best in all of her future endeavors.

City Manager Salerno reiterated the matter of outsourcing, that was brought up earlier by Commissioner Withers, but was further reminded by the Mayor that said matter will be brought back by Commissioner Withers for discussion of same; but stated that he believes the will of the City Commission is to hire another City Attorney; further adding that the Commission may want to appoint an interview committee; further instructing the City Manager to schedule for the second regularly scheduled meeting of October, 2010, a proposal as to how the City Commission will move this matter forward].
