

**AMENDMENT NO. 2  
TO AGREEMENT NO. C2207  
BETWEEN  
FLORIDA DEPARTMENT OF ENVIRONMENTAL PROTECTION  
AND  
CITY OF CORAL GABLES**

This Amendment to Agreement No. C2207, as previously amended, (Agreement) is made by and between the Department of Environmental Protection (Department), an agency of the State of Florida, and City of Coral Gables, 405 Biltmore Way, Coral Gables, Florida 33134 (Grantee), on the date last signed below.

WHEREAS, the Department entered into the Agreement with the Grantee for Sanitary Sewer Coastal Bay Service Area – Rehabilitation Phase I, effective June 9, 2023; and

WHEREAS, the parties wish to amend the Agreement as set forth herein to reflect statutory changes.

NOW THEREFORE, the parties agree as follows:

- 3) Attachment 3-A, Revised Grant Work Plan, is hereby deleted in its entirety and replaced with Attachment 3-B, Second Revised Grant Work Plan, as attached to this Amendment and hereby incorporated into the Agreement. All references in the Agreement to Attachment 3 shall hereinafter refer to Attachment 3-B, Second Revised Grant Work Plan.
- 4) Exhibit A, Progress Report Form, is hereby deleted in its entirety and replaced with Exhibit A-1, Progress Report and Deliverable Submission Form, as attached to this Amendment and hereby incorporated into the Agreement. All references in the Agreement to Exhibit A shall hereinafter refer to Exhibit A-1, Progress Report and Deliverable Submission Form.
- 5) All other terms and conditions of the Agreement remain in effect. If and to the extent that any inconsistencies may appear between the Agreement and this Amendment, the provisions of this Amendment shall control.
