RESOLUTION NO. 2025-165

A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE RECOMMENDATION OF THE CHIEF PROCUREMENT OFFICER TO AWARD LANDSCAPE SERVICES US1 MEDIANS TO BRIGHTVIEW LANDSCAPE SERVICES, INC., THE LOWEST RESPONSIVE AND RESPONSIBLE BIDDER, PURSUANT TO INVITATION FOR BIDS (IFB) 2025-001 AND SECTION 2-763 OF THE CITY'S PROCUREMENT CODE ENTITLED "CONTRACT AWARD".

WHEREAS, on January 31, 2025, the Procurement Division of Finance formally advertised, issued and distributed the IFB for Landscape Services US1 Medians; and

WHEREAS, one hundred and thirty-four (134) prospective bidders downloaded the IFB package from Infor, the City's web-based e-Procurement service; and

WHEREAS, on March 7, 2025, four (4) bids were received in response to the IFB 2025-001 from Brightview Landscape Service, Inc., Margarita's Gardens, Inc., SFM Landscape Services, LLC, and Superior Landscaping & Lawn Service, Inc.; and

WHEREAS, the Procurement Division finalized its' due diligence process and confirmed that Brightview Landscape Services, Inc., is both responsive to the requirements of the IFB and a responsible bidder; and

WHEREAS, the Public Works Department concurs with the Chief Procurement Officer's recommendation to award Landscape Services US1 Medians to Brightview Landscape Services, Inc.; and

WHEREAS, Section 2-585 of the Procurement Code, entitled "Authority" authorizes the City Manager to delegate authority to the Chief Procurement Officer to administer and make recommendations on contract awards;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:SECTION 1


SECTION 1. That the foregoing "**WHEREAS**" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Commission accepts the recommendation of the Chief Procurement Officer and authorizes the City Manager to award Landscape Services US1 Medians to Brightview Landscape Services, Inc., the lowest responsive and responsible bidder in an amount of \$294,163.36 pursuant to Invitation for Bids (IFB) 2025-001 and section 2-763 of the procurement code entitled "Contract Award".


SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.
