## **RESOLUTION NO. 2025-74**

A RESOLUTION OF THE CITY COMMISSION AUTHORIZING A CONTRACT MODIFICATION TO ROADWAY CONSTRUCTION, LLC. CONTRACT NO. IFB 2023-013 FOR THE PONCE DE LEON & GRANADA FORCE MAIN REPLACEMENT PROJECT, PURSUANT TO SECTION 2-764 (B) APPROVAL OF CHANGE ORDERS AND CONTRACT MODIFICATIONS, ALLOWING FOR CONTINGENCY ESTIMATED AT \$500,000 OR NOT TO EXCEED THE AVAILABLE BUDGET.

**WHEREAS,** on May 13, 2017, the City Commission approved the establishment of a pre-qualified pool of contractors for General and Specialty Trade Contractor Services, allowing Roadway Construction LLC. to bid on the Ponce de Leon & Granada Force Main Replacement project; and

**WHEREAS**, Roadway Construction LLC., was awarded this project as the lowest responsive and responsible bidder; and

**WHEREAS,** it is in the city's best interest to modify the spending authority in the amount not to exceed \$500,000 to allow for additional funds necessary to address additional and unforeseen conditions;

## NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

- **SECTION 1.** The foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.
- **SECTION 2.** That the City Commission authorize Roadway Construction, LLC.'s contract modification in the estimated amount of \$500,000 or not to exceed the available budget, pursuant to Section 2-764(b) of the City's Procurement Code.
- **SECTION 3.** That this Resolution shall become effective upon the date of its passage and adoption herein.
