**RESOLUTION NO. 2019-294**

A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE RECOMMENDATION OF THE CULTURAL DEVELOPMENT BOARD TO APPOINT NELSON DE LEÓN, JILL DEUPI, JACEK KOLASIŃSKI, EMILY MACDONALD-KORTH, MARIJEAN MIYAR, AND JUAN ROSELIONE-VALADEZ TO THE ARTS ADVISORY PANEL TO SERVE FOR THE REMAINDER OF A TWO (2) YEAR TERM, WHICH BEGAN ON JUNE 1, 2019 AND CONTINUES THROUGH MAY 31, 2021.

**WHEREAS**, the Arts Advisory Panel is comprised of nine (9) members, with the Cultural Development Board recommending seven (7) members' appointment to the City Commission; and

**WHEREAS**, on August 6, 2019 the Cultural Development Board voted to recommend reappointment of the current members of the Arts Advisory Panel, two of whom have served beyond the 8-year term limit and were therefore not recommended for reappointment; and

**WHEREAS**, one of the current members of the Arts Advisory Panel declined to accept the nomination for an additional term; and

**WHEREAS**, on August 6 and September 17, 2019 the Cultural Development Board voted to recommend appointment of two new members to the Arts Advisory Panel; and

**WHEREAS**, the following recommended appointees have agreed to serve: Nelson de León, Jill Deupi, Jacek Kolasinski, Emily MacDonald-Korth, Marijean Miyar, and Juan Roselione-Valadez;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** That the foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a part of this resolution upon adoption hereof.

**SECTION 2.** That the City Commission does hereby appoint Nelson de León, Jill Deupi, Jacek Kolasinski, Emily MacDonald-Korth, Marijean Miyar, and Juan Roselione-Valadez as members of the Arts Advisory Panel for the remainder of a two (2) year term, which began on June 1, 2019 and continues through May 31, 2021.

**SECTION 2.** That this Resolution shall become effective immediately upon the date of its passage and adoption herein.
