

This letter constitutes a notice that a violation(s) exists on the premises at:

Expired Building Permit - Sec. 105-26. - Adoption of building, plumbing, electrical and related technical codes.
The state building code together with all local amendments thereto is hereby adopted by reference. The Board has the authority to assess a fine against you for as long as the violation continues.
