## C. APPROVAL OF THE MINUTES

## D. NEW BUSINESS

## D.-1. BOARD MEETING TIME

A motion was made by Mr. Rodriguez, seconded by Mr. Fliss, to change the Cultural Development Board meeting time to 9:15 AM, which passed unanimously.

## D.-2. JEAN WARD SCULPTURE - UNDERLINE / DISCUSSION

Board members were presented with an overview of the Jean Ward sculpture collection and reviewed a Letter of Intent from the Underline to have certain artworks in the collection placed within the Underline. Board members discussed the needed restoration of some of the works, maintenance, and proposed locations. Members discussed wanting the pieces to remain within the city of Coral Gables and overall requested input from the Arts Panel before moving forward with a recommendation.


#### Abstract

A motion was made by Ms. Burgos, and seconded by Mr. Fliss, requesting a recommendation from the Arts Advisory Panel regarding the Jean Ward sculpture collection and possible placement within The Underline, further requesting a budget for restoration and consideration of the pieces remaining in the City of Coral Gables, which passed unanimously.

Board members were updated on the status of Cultural Grant applicant programs and requests. Members commented on the Alhambra Chamber Music Sunday afternoon performance and Actors Playhouse production of Legally Blonde. There were no change requests.

## G.-1. ART IN PUBLIC PLACES UPDATES

Board members were provided with Art in Public Places project updates as follows:

- Police \& Fire Memorial - Contractors for the Artist have changed. Looking at a late April completion date.
- Julio Larraz, Mars - artwork is in production and planned for completion in the next months.
- Centennial Commemorative artwork - proposals have been submitted and are available for public comment on the city website.
- Janine Antoni, Whispering Through A Stone - project is estimated for completion by December 2024.


## H. CITY COMMISSION ITEMS

Board members were advised that the Art in Public Places Ordinance Amendment is scheduled for the Planning and Zoning Board in March before returning to the Commission for second reading.

Staff reported that a date has not been set for the joint meeting with Economic Development Board to discuss including Cultural Arts as a goal of the city's strategic plan.

Board members were advised that the former Assistant City Manager has been appointed as the Interim City Manager.
