RESOLUTION 2023-

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF CORAL GABLES, FLORIDA, PROVIDING DIRECTION TO THE CITY MANAGER REGARDING IMPROVEMENTS TO MAJORCA PARK TO ALLOW FOR A DEDICATED OFF-LEASH DOG PLAY AREA AND AUTHORIZING AN AMENDMENT TO THE FISCAL YEAR 2022-2023 AMENDED BUDGET TO APPROPRIATE FUNDS FOR SAID IMPROVEMENTS

WHEREAS, Majorca Park is located at 937 Majorca Avenue and boasts a large playground and a native ficus aurea tree; and

WHEREAS, the residents of Coral Gables have expressed an interest in having more dedicated off-leash dog play facilities in the City, and the City is aware of a petition calling for off-leash dog play areas at Majorca Park; and

WHEREAS, as a centrally located and popular park the City Commission believes Majorca Park and the community would be well served by dedicating a vacant, unused portion of the park as a dedicated off-leash dog play area; and

WHEREAS, the City anticipates that the dedicated off-leash dog play area would be fenced off in a manner similar to the temporary area at Catalonia Park that currently acts as a dedicated off-leash dog play area.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

- **SECTION 1.** That the foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.
- **SECTION 2.** That the City Commission directs the City Manager to make improvements to Majorca Park in order to allow for a dedicated off-leash dog play area within the park, and requests that the City staff attempt to mirror those improvements made at Catalonia Park.
- **SECTION 3**. That the City Commission authorizes an amendment to the Fiscal Year 2022-2023 Amended Budget, in the amount needed to facilitate those improvements discussed above and approved by the City Commission.

SECTION 4. That this Resolution shall become effective upon the date of its passage and adoption herein.
