A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE RECOMMENDATION OF THE CHIEF PROCUREMENT OFFICER TO AWARD DUMPSTER BAY RENOVATIONS TO ATLAS DOOR & GATE INC, AS THE LOWEST RESPONSIVE AND RESPONSIBLE BIDDER, IN THE ESTIMATED AMOUNT OF \$45,604.96 BUT NOT TO EXCEED BUDGETED FUNDS, PURSUANT TO INVITATION FOR BIDS (IFB) 2025-047 AND SECTION 2-763 OF THE CITY'S PROCUREMENT CODE ENTITLED "CONTRACT AWARD".

WHEREAS, on December 3, 2025, the Procurement Division of Finance formally advertised, issued and distributed IFB 2025-047 Dumpster Bay Renovations. Two hundred and four (204) prospective bidders were notified through INFOR, the City's web-based e-Procurement system; and

WHEREAS, on December 10, 2025, a non-mandatory pre-bid conference was held; and

WHEREAS, on January 14, 2025, four (4) bids were received in response to the IFB from: Atlas Door & Gate Inc, Gavarrete Inc., M&J Consulting Group Corp. d/b/a M&J General Contractors, and Team Contracting, Inc.; and

WHEREAS, the Public Works Department concurs with the Procurement Officer's recommendation to award Atlas Door & Gate Inc. as the lowest responsive and responsible bidder in the estimated amount of \$45,604.96 or not to exceed budgeted funds; and

WHEREAS, Section 2-585 of the Procurement Code, entitled "Authority" authorizes the City Manager to delegate authority to the Procurement Officer to administer and make recommendations on contract awards.

NOW THEREFORE BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

Section 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

Section 2. That the City Commission accepts the recommendation of the Chief Procurement Officer and authorizes the City Manager to award the Dumpster Bay Renovations contract to Atlas Door & Gate Inc., as the lowest responsive and responsible bidder in the estimated amount of \$45,604.96 or not to exceed budgeted funds pursuant to Section 2-763 of the Procurement Code entitled "Contract Award" and Invitation for Bids (IFB) 2025-047.

Section 3. That this Resolution shall become effective upon the date of its adoption herein.
