RESOLUTION NO. 2023-278

A RESOLUTION OF THE CITY COMMISSION DIRECTING THAT CITY STAFF AMEND THE PROPOSED ANNUAL BUDGET OF ESTIMATED REVENUES AND EXPENDITURES FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2023 AND ENDING SEPTEMBER 30, 2024 PRIOR TO THE SECOND READING OF THE ORDINANCE ADOPTING SAID BUDGET IN ORDER TO REALLOCATE FUNDS IN THE CAPITAL PROJECTS BUDGET FROM YOUTH CENTER DESIGN TO THE RESTORATION OF THE ALHAMBRA WATER TOWER

WHEREAS, on September 13, 2023 the City Commission considered, and adopted on first reading an ordinance adopting the annual budget of estimated revenues and expenditures for the 2023-2024 Fiscal Year; and

WHEREAS, that proposed budget includes \$500,000 of funding for the design of the Youth Center project;

WHEREAS, the City Commission has identified an immediate need for the restoration of the Alhambra Water Tower; and

WHEREAS, the City Commission directs City staff to amend the proposed budget prior to second reading to re-allocate \$250,000 from the \$500,000 proposed funding from the design of Youth Center project to the Alhambra Water Tower restoration capital project.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. The City Commission directs City staff to amend the proposed budget prior to second reading to re-allocate \$250,000 from the \$500,000 proposed funding from the design of Youth Center project to the Alhambra Water Tower restoration capital project.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.
