ACCEPTING RESOLUTION THE RECOMMENDATION **OF** THE **CHIEF** PROCUREMENT OFFICER TO AUTHORIZE A **SOFTWARE** APPLICATION **SUPPORT** AGREEMENT FOR CITYWIDE POLICE AND FIRE 911 DISPATCH SOFTWARE, **RECORDS** MANAGEMENT SYSTEM. AND **MOBILE** COMMUNICATION SOFTWARE LICENSES WITH OPEN SOFTWARE SUPPORT SOLUTIONS, D/B/A SUNGARD PUBLIC SECTOR, INC., IN THE **AMOUNT OF \$1,161,480.20 FOR A FIVE (5) YEAR** PERIOD UNDER SECTION 2-678 (10) OF THE PROCUREMENT CODE ENTITLED, EXEMPTIONS (COPYWRITE MATERIAL).

WHEREAS, on December 12, 2001, the City Commission approved an agreement for application software support with Open Software Support Solutions, d/b/a SunGard Public Sector, Inc. with option to renew after the first year of the contract; and

WHEREAS, this agreement has been renewed each year for a period of ten (10) years; and

WHEREAS, contracts may not be extended for more than ten (10) years under Section 2-825 of the Procurement Code, a new five (5) year contract is proposed in order to maintain this proprietary software; and

WHEREAS, under Section 2-678 (10) of the Procurement Code entitled "Exemptions," this new Application Software Support Agreement is exempted from the Procurement Code as "copywrite material" and thus, is not subject to the formal solicitation requirements; and

WHEREAS, it is also in the best interest of the City to enter into this new agreement for application software support instead of abandoning the current computer aided software that has been in place for ten (10) years in favor of soliciting a new and potentially more costly and unproven software product: and

WHEREAS, the Chief Procurement Officer recommends that a new application software support agreement be authorized for a period of five (5) years; and

WHEREAS, Section 2-650 of the Procurement Code authorizes the City Manager to delegate authority to the Chief Procurement Officer to administer and make

recommendations on City contracts.

NOW THEREFORE BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

Section 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

Section 2. That the City Commission accept the recommendation of the Chief Procurement Officer to authorize a new Application Software Support Agreement with Open Software Support Solutions, d/b/a SunGard Public Sector, Inc., for a five (5) year period.

Section 3. That all Resolutions or parts of Resolutions inconsistent with, or in conflict herewith, shall be and are hereby repealed insofar as there is conflict or inconsistency.

Section 4. That this Resolution shall become effective upon the date of its adoption herein.
