RESOLUTION NO. 2023-07

A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE RECOMMENDATION OF THE CHIEF PROCUREMENT OFFICER TO AWARD THE WATERWAY BANK STABILIZATION PROJECT TO ENCO, LLC, THE LOWEST RESPONSIVE AND RESPONSIBLE BIDDER, IN THE ANNUAL ESTIMATED AMOUNT OF \$473,625, PURSUANT TO INVITATION FOR BIDS (IFB) 2022-019 AND SECTION 2-763 OF THE CITY'S PROCUREMENT CODE ENTITLED "CONTRACT AWARD".

WHEREAS, on September 21, 2022, the Procurement Division of Finance formally advertised, issued and distributed the IFB for Waterway Bank Stabilization; and

WHEREAS, forty-nine (49) prospective bidders downloaded the IFB package from Public Purchase, the City's web-based e-Procurement service; and

WHEREAS, on October 28, 2022, five (5) bids were received in response to the IFB 2022-019 from ACRE Engineering and Construction, Inc., ENCO, LLC, Marcdan. Inc., Metro Equipment Service, Inc., and Sea & Shoreline, LLC; and

WHEREAS, the Public Works Department concurs with the Chief Procurement Officer's recommendation to award the Waterway Bank Stabilization Project to ENCO, LLC; and

WHEREAS, Section 2-585 of the Procurement Code, entitled "Authority" authorizes the City Manager to delegate authority to the Procurement Officer to administer and make recommendations on contract awards;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Commission accepts the recommendation of the Chief Procurement Officer authorizing the City Manager to award the Waterway Bank Stabilization to ENCO, LLC, the lowest responsive and responsible bidder in the estimated amount of \$473,625 but not to exceed the available and approved budget, pursuant to Invitation for Bids (IFB) 2022-019 and section 2-763 of the procurement code entitled “contract award”.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.

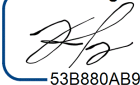

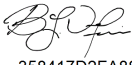
