ORDINANCE NO. 2010-26

AN ORDINANCE OF THE CITY COMMISSION OF CORAL GABLES AUTHORIZING THE CITY MANAGER TO APPROVE ACTIVITIES AT THE BANK UNITED CENTER ON THE UNIVERSITY OF MIAMI CAMPUS OF THE UNIVERSITY TO EXCEED ONE THOUSAND AND SIX HUNDRED (1,600) SPECTATORS ON OCTOBER 26, 2010, NOTWITHSTANDING IMITATIONS IMPOSED ON THE NUMBER OF SPECTATORS BY PRIOR UMCAD APPROVALS IN CERTAIN LIMITED CIRCUMSTANCES, PROVIDING CONDITIONS FOR APPROVAL, SAVINGS CLAUSE AND A REPEALER CLAUSE, AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, the previously approved UMCAD limits the use of the Bank United Center on the University of Miami Campus during the regular academic year between the hours of 8 AM and 4 PM to one thousand and six hundred (1,600) spectators; and

WHEREAS, the limitation on the number of spectators was intended to avoid traffic congestion and parking demand in excess of existing parking capacity assuming access by way of private automobiles; and

WHEREAS, the University of Miami proposes to host a one-time event involving His Holiness, the Dalai Lama on October 26, 2010 between 1:00 p.m. and 3:00 p.m.; and

WHEREAS, the Dalai Lama is a Head of State and therefore security for the planned event will be provided by the Department of State; and

WHEREAS, the University of Miami has prepared a special event management plan and a parking management plan for the on-time event to address the increase in spectators; and

WHEREAS, the University's special event management plan provides for close coordination with the City of Coral Gables Police Department and for the University to be responsible for the cost of any additional security;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Ordinance upon adoption hereof.

SECTION 2. That the City Commission does hereby authorize the City Manger to proceed with the planned Dalai Lama special event scheduled for October 26, 2010, notwithstanding any provision of a prior UMCAD approval.

SECTION 3. That it is the intent of the City Commission that the decision with regard to the planned Dalai Lama special event on October 26, 2010 is based on the specific facts of any particular proposed activity shall not be considered as precedent for any other particular proposed activity and is in the nature of a license and shall not be considered as a precedent for any other activity at the Bank United Center, no matter how similar.

SECTION 4. That all ordinances or parts of ordinances inconsistent with or in conflict herewith shall be and are hereby repealed insofar as there is a conflict or inconsistency.

SECTION 5. That this Ordinance shall become effective ten (10) days after final reading and adoption thereof.


