RESOLUTION NO. 2009-80

A RESOLUTION OF THE CITY OF CORAL GABLES AUTHORIZING THE AWARD OF THE OLD CUTLER FORCE MAIN REPLACEMENT – PHASE III PROJECT TO GMI CONTRACTING, INC. PURSUANT TO SECTION 2-828 OF THE PROCUREMENT CODE, IN THE AMOUNT OF \$609,319.00 (SIX HUNDRED NINE THOUSAND THREE HUNDRED NINETEEN DOLLARS). (PROJECT TO BE FUNDED BY THE SANITARY SEWER FUND).

WHEREAS, on January 22, 2009 the Procurement Division of Finance formally advertised, issued and distributed the Old Cutler Force Main Replacement – Phase III Invitation to Bid (IFB) 2009-01-20; and

WHEREAS, on March 12, 2009 twenty four (24) bid responses were received. Of those that responded seventeen (17) responsive bids were submitted by Acosta Tractors, Inc., Cisca Group, Conquest Engineering, Downrite Engineering, GMI Contracting, JVA Engineering, Master Excavators, Metro Equipment, Persant Construction, R&G Engineering, Ram-Tech Construction, Rock Power Paving, Solo Construction, Solution Construction, Tran Construction, UniTech Builders, VPI; and

WHEREAS, there were seven (7) No Bid responses from Alpine Construction, Budget Construction Co. Inc., Danella Utility Construction, Inc., Development & Communication Group, Largo Development, Inc., Miguel Lopez, Jr. Inc., and Wrangler Construction;

NOW, THEREFORE, BE IT ORDAINED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing “Whereas” clause are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City of Coral Gables Commission does hereby accept the recommendation of the City Manager pursuant to the Invitation to Bid (IFB) No. 2009-01-20 to select GMI Contracting, Inc. for the Old Cutler Force Main Replacement – Phase III project; having been recommended by the City’s Consultant, Hazen & Sawyer, Inc., and the Public Works Department; further stating that said service will be funded by the Sanitary Sewer Fund.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.


