RESOLUTION NO. 2004-91

A RESOLUTION AUTHORIZING THE CITY MANAGER TO EXECUTE A JOINT PARTICIPATION AGREEMENT BETWEEN MIAMI-DADE COUNTY AND THE CITY OF CORAL GABLES FOR DISBURSEMENT OF ROAD IMPACT FEE FUNDS TO THE CITY FOR THE DESIGN AND CONSTRUCTION OF ROADWAY IMPROVEMENT PROJECTS AT SEVERAL LOCATIONS, AS SHOWN ON EXHIBIT "A".

BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. That a Joint Participation Agreement has been prepared by Miami-Dade County to disburse Road Impact Fee funds to the City of Coral Gables for the design, construction, and inspection of roadway improvements at several locations throughout the City of Coral Gables, as shown on Exhibit "A", attached.

SECTION 2. That the City Manager is authorized to execute said Joint Participation Agreement between Miami-Dade County and the City of Coral Gables.

SECTION 3. That the executed Agreement shall be made a part of this Resolution and be kept on file in the office of the City Clerk.

SECTION 4. That this Resolution shall become effective upon the date of its adoption herein.


