NARRATIVE

On Saturday, September 24th, 2022, at approximately 0954 hours, I responded to the residence of 134 Florida Av, in reference to a report of four Hispanic males possibly trespassing inside the abandoned residence. Upon arrival, I met with Mr. Carl Prime (Reporter). He advised the following:

At approximately 0950 hours, he observed a white work pickup truck (unknown tag, make, model) drop off four Hispanic males, wearing "work clothing." Mr. Prime stated he knows the home is currently vacant and stated "Illegal" work has been done at the property before without permits. As I walked around the residence, I did not observe any vehicles in front of the home or persons outside. Officer Menocal and I approached the front door of the residence and could clearly hear movement inside the home. As we knocked on the door, the noise of movement stopped. I announced myself as "Coral Gables Police" multiple times with negative results. As I walked along the exterior of the home, all windows were covered with trash bags and all doors were locked. Unable to contact any persons inside the home, we left the area. Mr. Prime was provided with a case card and was advised that this incident would be documented and forwarded to code enforcement.
