RESOLUTION NO. 2024-237

A RESOLUTION OF THE CITY COMMISSION ACCEPTING A RECOMMENDATION OF THE CITY MANAGER TO WAIVE THE COMPETITIVE PROCESS OF THE PROCUREMENT CODE FOR THE PURCHASE OF CONTROL PANELS FOR NORTH GABLES & CITY 4 STORMWATER PUMP STATIONS FROM CUSTOM CONTROLS TECHNOLOGY, INC. AS A “SOLE SOURCE PROCUREMENT”, PURSUANT TO SECTION 2-689 OF THE CITY’S PROCUREMENT CODE.

WHEREAS, the purchase of the control panels for the Stormwater Pump Stations City 4 and North Gables, located at 3940 Granada Boulevard and 1406 Granada Boulevard, is part of an upgrade project for both stations; and

WHEREAS, this upgrade aims to enhance the functionality and equipment of the stations, ensuring they operate more efficiently; and

WHEREAS, new control panels will be integral to these improvements, providing advanced features and better performance to support the overall stormwater management system; and

WHEREAS, Custom Controls Technology, Inc. holds the exclusive patent for manufacturing flood-resistant control panels, making them the only company authorized to produce and supply these specialized panels. No other company is permitted to manufacture or provide these flood-resistant control panels, ensuring that only Custom Controls Technology, Inc. can sell them; and

WHEREAS, the cost for this work is estimated at \$132,126 and Public Works is seeking approval for this amount or an amount not to exceed the available budget; and

WHEREAS, Section 2-689 of the Procurement Code entitled “Sole Source Procurement” authorizes an award without competitive bids when there is only one source available to fulfill the needs of the City; and

WHEREAS, Section 2-585 of the Procurement Code, entitled “Authority” authorizes the City Manager to delegate authority to the Procurement Officer to administer and make recommendations on contract awards;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:


SECTION 1. The foregoing “WHEREAS” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Commission accepts a recommendation to waive the competitive process and authorizes the City Manager to award Custom Controls Technology, Inc., pursuant to Section 2-689 of the City’s Procurement Code.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.


