RESOLUTION **ACCEPTING** THE RECOMMENDATION OF THE **CHIEF** PROCUREMENT OFFICER TO AWARD THE CHANNEL MARKER REPLACEMENT CONTRACT DOCK AND MARINE CONSTRUCTION. PURSUANT TO INVITATION FOR BID (IFB) AND SECTION 2-828 OF 2014.08.07. THE PROCUREMENT CODE ENTITLED "CONTRACT AWARD".

WHEREAS, the Chief Procurement Officer pursuant to Section 2-828 of the Procurement Code entitled "Contract Award" and Invitation for Bid (IFB) 2014.08.07 recommends that Dock and Marine Construction, be awarded the Channel Marker Replacement project; and

WHEREAS, Section 2-650 of the Procurement Code authorizes the City Manager to delegate authority to the Chief Procurement Officer to administer and make recommendations on City contracts;
