RESOLUTION NO. 2014-198

RESOLUTION ACCEPTING THE
RECOMMENDATION OF THE CHIEF
PROCUREMENT OFFICER TO AWARD THE
CHANNEL MARKER REPLACEMENT CONTRACT
TO DOCK AND MARINE CONSTRUCTION,
PURSUANT TO INVITATION FOR BID (IFB)
2014.08.07, AND SECTION 2-828 OF THE
PROCUREMENT CODE ENTITLED "CONTRACT
AWARD".

WHEREAS, on August 7, 2014, the Procurement Division of Finance formally advertised issued and distributed the Channel Marker Replacement IFB 2014.08.07; and

WHEREAS, on September 10, 2014, one (1) responsive responsible bid was submitted by Dock and Marine Construction with a bid of \$45,300; and

WHEREAS, the Chief Procurement Officer pursuant to Section 2-828 of the Procurement Code entitled "Contract Award" and Invitation for Bid (IFB) 2014.08.07 recommends that Dock and Marine Construction, be awarded the Channel Marker Replacement project; and

WHEREAS, Section 2-650 of the Procurement Code authorizes the City Manager to delegate authority to the Chief Procurement Officer to administer and make recommendations on City contracts;

NOW, THEREFORE, BE IT ORDAINED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

Section 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

Section 2. That the City Commission accepts the recommendation of the Chief Procurement Officer to award the Channel Marker Replacement contract to Dock and Marine Construction, pursuant to Invitation for Bid (IFB) 2014.08.07, and Section 2-828 of the Procurement Code entitled "Contract Award", subject to final approval and execution of a contract by City staff.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.
