RESOLUTION NO. 2023-354

A RESOLUTION OF THE CITY COMMISSION AUTHORIZING THE RATIFICATION OF AN EMERGENCY AUTHORIZATION OF A CRITICAL RESURFACING PROJECT NEEDED TO GET THE CLAY TENNIS COURTS BACK TO SAFE PLAYING CONDITIONS AT THE SALVADORE PARK TENNIS CENTER LOCATED AT 1120 ANDALUSIA AVENUE, FOLLOWING THE STORM ON NOV. 15, 2023, PURSUANT TO SECTION 2-690 EMERGENCY PROCUREMENT, IN THE AMOUNT OF \$200,000.

WHEREAS, on the evening of Wednesday, Nov. 15, 2023, a severe storm came through with excessive rain and wind which in part flooded the courts resulting in severe loss of clay material and damage to the tennis courts at the Salvadore Park Tennis Center; and

WHEREAS, for the safety of players and instructors, as the eroded material may lead to injuries, a larger resurfacing project is needed to get the courts back to safe playing conditions; and

WHEREAS, repairs will include the resurfacing of thirteen clay tennis courts, removal of visible surface algae and dead material, removal of old lines and nails, application of new material, installment of new herringbone style line tapes to USTA specifications, repainting of net posts and reinstalment of existing tennis nets and center straps; and

WHEREAS, the requested emergency authority is in the amount of \$200,000 to cover any unforeseen additional costs to the quoted project repairs;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing “**WHEREAS**” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.


SECTION 2. That the City Commission approves the emergency repairs in the amount of \$200,000 for this project, pursuant to Section 2-690 of the City’s Procurement Code.


