Dear Property Owner and/or Occupant:

This letter constitutes a notice that a violation(s) exists on the premises at:
800 PARADISO AVE, Coral Gables, FL 33146--2043

The violation(s) found was:

Permits generally (c) - Tree Abuse - Sec. 82-29. - Permits generally.
(c) Tree abuse. Tree abuse is prohibited and shall constitute a violation of this section. Any act of tree abuse that renders a tree nonviable or effectively destroyed shall constitute "effective removal" and shall compel the owner to fully comply with the terms of this article as if the tree was removed prior to issuance of a permit.

Code Enforcement Officer Comments: Cut a Live Oak tree and a Gumbo Limbo tree on city right of way without a permit. Improper tree pruning. Tree abuse.

The following steps should be taken to correct the violation:

Comply with Section 82-29. Must obtain a after-the-fact permit for tree cutting. Must submit a Arborist report, written by a Florida state, certified arborist to Coral Gables Greenspace division as to the viability of the tree, and any corrective measures needed. Contact Greenspace for additional requirements. 305-460-5000.

The regulations enforced by the City have been adopted in order to protect the public and assure continuing high property values. Your immediate attention to correcting the violation(s) listed above is required.

The Code Enforcement Division will re-inspect the property on 11/9/2023 to determine if corrective measures have been completed. If the violation(s) has not been completed at the time of inspection, your case will be presented to the Code Enforcement Board for review and possible action. At that time, you will have the opportunity to explain to the citizens serving on the Board the reasons why the violation(s) has not been corrected. The Board has the authority to assess a fine against you for as long as the violation continues.
