## **6. CHAIR COMMENTS**

## Round Table:

- Improvement to the Dog Park on the West side of Matheson Hammock's; this is important to many individuals.
- Board Member Kutner commented on abandoned boats that are anchored in the waterways create a navigational hazard since these boats have no lights, and no markings. Ms. Granell will find out what type of enforcements are warranted for these hazardous boats on the waterways.
- Board Member Schragger mentioned that additional and clear marine instructions ahead of time are crucial to be ready for a potential hurricane.
- Board Member Schragger shared her concern on the overgrown mangroves and how to best address this matter.
- Board Member Davis discussed her concern on the canal that goes down to Journey's End was twice the width that it's currently. What is being done about this?
- House located at 400 Solano Prado is not kept orderly, neat and clean.
- Board Member Martinez addressed a concern over a specific house which has been under construction for the past ten years.
- Chairperson Sanabria addressed trash pickup. This has been a continuous concern.
- Board Member Quevedo expressed concern regarding children, specifically between the ages of 10 and 13, operating dirt bikes at high speeds. He emphasized that this behavior poses a significant safety risk. He recommended the implementation of regulations governing the use of dirt bikes and golf carts to enhance community safety.

Ms. Granell explained that the city has a Hurricane Preparedness Plan set in place. At the state level, there are additional requirements that the city must comply with. In addition to the hurricane-specific plan, the city also maintains a comprehensive Emergency Preparedness Plan, which includes a series of compliance targets. Furthermore, the city has established several different levels of emergency response to ensure a coordinated and effective reaction in various situations.

Additional details will be provided along with presentations etc.

Ms. Santiago confirmed that the city manager has been actively having Hurricane Preparedness meeting with every department within the city.

Board member Martinez inquired about any hurricane implications pursuant to those individuals currently located at the location called Alligator Alcatraz in the event they need to be relocated.

Ms. Granell indicated that to her knowledge there has been no communication with the city manager; however, Ileana Garcia is actively involved with the Alligator Alcatraz matter.

Immediate issues of concern:

- Park that was going to be held in Matheson Hammocks would increase road traffic by flow by 400 %. There has been no update on this.
