

**CITY OF CORAL GABLES, FLORIDA**

**RESOLUTION NO. 2009-61 (As Amended)**

A RESOLUTION OF THE CORAL GABLES CITY COMMISSION AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT WITH THREE DEBRIS REMOVAL COMPANIES, NAMELY ASHBRITT, INC., AS PRIMARY CONTRACTOR FOR DEBRIS MANAGEMENT SERVICES, CERES ENVIRONMENTAL AND JB COXWELL DISASTER RECOVERY SERVICES AS THE SECONDARY OR BACKUP CONTRACTORS; FURTHER STIPULATING THAT SAID CONTRACT SHALL BE FOR A PERIOD OF THREE (3) YEARS WITH THE OPTION TO RENEW FOR AN ADDITIONAL TWO (2) THREE (3) YEAR PERIODS.

**WHEREAS**, on May 16, 2008 the Procurement Division of Finance formally advertised, issued and distributed the Debris Management Service Request for Proposal (RFP) No. 2008.05.05; and

**WHEREAS**, on June 12, 2008 ten (10) responses were received; Bergeron Emergency Services, Ceres Environmental Services, Inc, AshBritt, Inc, Phillips & Jordan, Inc, JB Coxwell Disaster Recovery Services, ATL Disaster Recovery, Storm Reconstruction Services (SRS), Inc, DRC Emergency Services, LLC, Crowder Disaster Recovery, and D&J Enterprises, Inc. ATL Disaster Recovery was considered non responsive because it did not provide a 5% Bid Bond as requested on the RFP; and

**WHEREAS**, on June 18, 2008 the Selection Committee completed their evaluation based on Qualifications/Experience, Operational Plan for the City, Resources/Availability, Past Performance and Pricing and ranked AshBritt, Inc, Ceres Environmental and JB Coxwell Disaster Recovery as the three (3) highest proposers; and

**WHEREAS**, on June 26, 2008 the City Commission authorized the City Manager to negotiate a standard pricing structure with the three highest proposers; and

**WHEREAS**, efforts to negotiate a standard pricing structure with the three highest proposers were unsuccessful, and as a result it is recommended that the City Commission authorize the City Manager to execute contracts with the three (3) highest proposers based on their original proposals of June 12, 2008;

**NOW, THEREFORE, BE IT ORDAINED BY THE COMMISSION OF THE  
CITY OF CORAL GABLES:**

**SECTION 1.** The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** That the City Commission does hereby accept the recommendation of the City Manager pursuant to the Request for Proposal (RFP) No. 2008.05.05 to select Ashbritt, Inc., as the primary contractor for debris management services, and Ceres Environmental and JB Coxwell Disaster Recovery Services, as the secondary or backup contractors for the Debris Management Services project; further authorizing the City Manager to sign and execute a three (3) year contract with the option to renew for two (2) three (3) year periods.

**SECTION 3.** That all Resolutions or parts of Resolutions inconsistent with, or in conflict herewith, shall be and are hereby repealed insofar as there is conflict or inconsistency.

**SECTION 4.** That this Resolution shall become effective immediately upon the date of its passage and adoption herein.


