## **RESOLUTION NO. 2023-248**

A RESOLUTION OF THE CITY COMMISSION APPROVING THE INSTALLATION AND LOCATION FOR THE DONATED CLOCK FROM F.P. JOURNE ON THE NORTHWEST CORNER OF THE INTERSECTION OF MIRACLE MILE AND PONCE DE LEON.

- **WHEREAS,** F.P. Journe, a world-renowned boutique watchmaker that produces only 800 watches a year, has generously donated a clock to the City of Coral Gables with the intent of enhancing the aesthetic and cultural appeal of the City; and
- **WHEREAS**, the City Commission recognizes the significant value of this donated clock as a unique and artistic addition to the urban landscape of Coral Gables and accepted the donation pursuant to Resolution 2023-104; and
- **WHEREAS**, the proposed location for the installation of the donated clock is the northwest corner of the intersection of Miracle Mile and Ponce de Leon, a central and highly visible location within the City; and
- **WHEREAS**, the installation of the clock in this specific location is expected to contribute to the vibrancy and cultural identity of Coral Gables and is consistent with the City's commitment to public art and community enhancement;

## NOW, THEREFORE, BE IT RESOLVED BY THE TRANSPORTATION ADVISORY BOARD OF THE CITY OF CORAL GABLES:

- **SECTION 1.** That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.
- **SECTION 2.** That the City Commission hereby approves the installation of the donated clock from F.P. Journe on the northwest corner of the intersection of Miracle Mile and Ponce de Leon and any associated costs for the installation will be paid by the City Mayor is his personal capacity.
- **SECTION 3.** The City Manager is authorized and directed to take all necessary actions to facilitate the installation of the clock at the approved location, including coordinating with F.P. Journe or its representatives.
- **SECTION 4.** This Resolution shall become effective upon the date of its passage and adoption herein.
