Mayor Lago: Mr. Clerk.

City Clerk Urquia: First speaker for Public Comment, Mr. Mayor, is Mrs. Maria Cruz.

Mrs. Cruz: Mrs. Maria Cruz, 1447 Miller Road. This is the day the Lord has made. Let us rejoice and be glad in it. It's not a happy day for me, but I have something to say.
